- A. <u>Application Fee</u> Payable once, non-refundable, during application. SGD299.60 (incl. GST).
- B. <u>Enrolment Fee</u> Payable once, non-refundable, after accepting a place with The Grange. Confirmation of a place will not be considered without this fee. SGD2,996 (incl. GST).
- C. <u>Promotional Course Fee</u> Payable within five working days of the first day of each term, non-refundable three terms per year. Includes books, stationery, equipment but excludes field trips and uniform. SGD6,602.90 (incl. GST); regardless of the length of the term. Please refer to the course fees below.

#### **REFUND POLICY**

# 1. Refund for Withdrawal Due to Non-Delivery of Course:

The PEI will notify the Student within three (3) working days upon knowledge of any of the following:

- (i) It does not commence the Course on the Course Commencement Date;
- (ii) It terminates the Course before the Course Commencement Date;
- (iii) It does not complete the Course by the Course Completion Date;
- (iv) It terminates the Course before the Course Completion Date;
- (v) It has not ensured that the Student meets the course entry or matriculation requirement as set by the organisation within any stipulated timeline set by CPE.

The Student should be informed in writing of alternative study arrangements (if any), and also be entitled to a refund of the entire Course Fees and Miscellaneous Fees already paid should the Student decide to withdraw, within seven (7) working days of the above notice.

### 2. Refund for Withdrawal Due to Other Reasons:

If the Student withdraws from the Course for any reason other than those stated in item no. 1, the PEI will, within seven (7) working days of receiving the Student's written notice of withdrawal, refund to the Student an amount based on the refund table below.

# 3. Refund During Cooling-Off Period:

The PEI will provide the Student with a cooling-off period of seven (7) working days after the date that the Contract has been signed by both parties.

The Student will be refunded the highest percentage stated in refund table of the fees already paid if the Student submits a written notice of withdrawal to the PEI within the cooling-off period, regardless of whether the Student has started the course or not.
